The firm has more than 15 years experience and a demonstrable track record of investing in U.S. small-caps

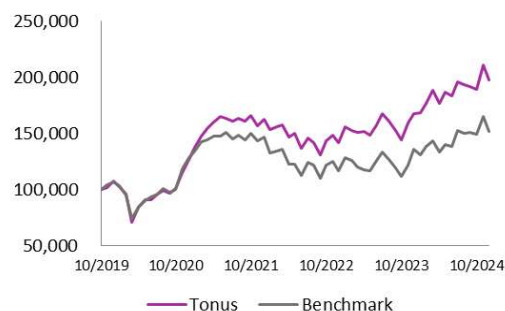
The firm's smaller size allows for faster and nimbler transactions in a structured approach
